The Annual Meeting of the Membership of the North Texas Eventing Association will be held on:

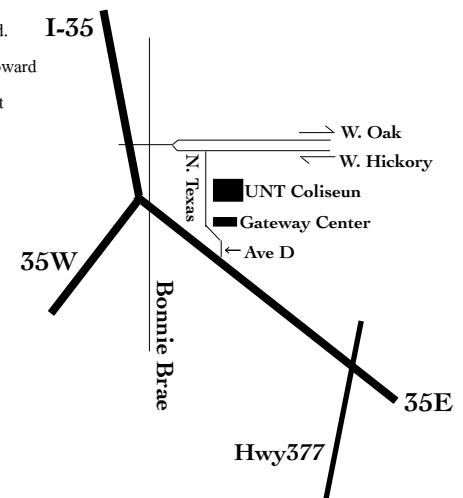
Saturday 6 February at 5:30 p.m.

From the South on I-35E: Exit at the 377 ramp but stay on the I-35W frontage to Ave D/ N. Texas Blvd, turn right.

From the South on I-35W: Take exit 85A toward Dallas on I-35E southbound, proceed to exit 466B to N. Texas Blvd. Merge on to I-35W frontage and turn left at Ave D/ N. Texas Blvd.

From the North on I-35: Travelling southbound on I-35, continue onto the I-35E south toward Dallas, proceed to exit 466B to N. Texas Blvd. Merge on to I-35W frontage and turn left at Ave D/ N. Texas Blvd.

The following amendments to the Bylaws are also proposed (text in red will be stricken and text in green will be added.):

Article Four. OFFICERS

The officers of the Association shall consist of a President, an Executive Vice President, a Secretary, a Treasurer, a Vice President - Activities, a Vice President - Membership, and a Vice President - Public Relations, and a Vice President - Young Riders.

More than one office may be held at one time by the same person, except for the office of President. The officers shall be elected at the Annual Meeting, as defined in Article Twelve.

Article Six. BOARD OF DIRECTORS

Section One. The Board shall consist of not less than 3 nor more than 10 11 members and shall include all officers of the Association.
